However, it was felt that with the nets in place it would leave only a small safety area therefore it was felt that with goals it would be unsafe. £150 net on wheels as an alternative – RESOLVED to approve to purchase – ACTION – Would need court cleaned – Cllr Hawkings and Clerk to arrange.
